

Wellness Centre “Spot & Win” Contest (“the Contest”) is organized by Sunway Medical Centre (“the Organizer”).

1. Duration

- 1.1 This Contest begins and ends as per stated on the contest post (“the Contest Period”)
- 1.2 The Organizer may at its sole and absolute discretion extend the Contest Period at any time without any prior notice to any party (“the Extended Period”). Unless an Extended Period is announced, any entries received after the end of the Contest Period (due to any reason howsoever and/or whatsoever arising) shall be disqualified. Any participation in the Contest during the Extended Period (if any) shall be governed by these terms and conditions (“Terms and Conditions”) which shall remain in full force and effect.

2. Eligibility

- 2.1 The Contest is open to Malaysian citizens aged 18 and above as of 1 January 2018. Employees, doctors, consultants and immediate families of The Organizer and its agencies are not eligible to participate in this Contest. Participants under the age of 18 years old as at 1 January 2018 must obtain consent of parents or legal guardians and by participating in this Contest, it is deemed that consent has been obtained.
